- 1. The "Board" means Vienna Music Examination Board.
 - "考試局"指維也納音樂考試局。
- 2. The processing time for new registration/renewal normally takes about two weeks upon received all required documents and applicable fees. The Board has the sole discretion right whether to approve or reject any registration/renewal without giving any reasons. To cover the Board's administration cost, any payment made are non-refundable and non-transferable in any cases including but not limited to the event that your registration or renewal is not approved.

- 3. VMEB Certified ECME Trainer must strictly follow all relevant rules and regulations set by the Board, which may be amended by the Board from time to time at the Board's sole discretion. Any rights granted by the Board are non-exclusive.

VMEB Certified ECME Trainer agreed to fully indemnify, defend and hold the Board (including the Board's associates and affiliates) harmless from and against any and all claims, lawsuits, actions, proceedings, demands, damages, costs and expenses whatsoever arising out of or relating to any activities conducted, whether directly or indirectly, by VMEB Certified ECME Trainer, and agreed that the Board shall not be held any responsibilities and liabilities to VMEB Certified ECME Trainer and anyone for any direct, indirect, incidental, special or consequential loss or damages, liabilities and claims, if any, arising from any activities conducted by VMEB Certified ECME Trainer.
