Exam Venue

Candidates may choose to take the exam at any of the Board's exam centres in Vienna or overseas (except Hong Kong). Candidates wishing to take exam in Hong Kong must use the Exam Registration Form applicable for Hong Kong region, which is available from the Board's official website. Candidates must make pre-arrangement with their chosen exam centre before taking the exam.

Exam Centre Fee

There will be additional fees charged by the Board's exam centres including (1) exam room rental fee; and (2) exam supervisor fee. Such fees vary between different exam centres and shall be paid by candidates to exam centre directly. Candidates are advised to confirm the exact amount of fees with their chosen exam centre before registering the exam. The Board shall not be held any liabilities and responsibilities on any fees paid by anyone to exam centres.

Exam Date

Candidates must take the exam on or before the exam due date shown in the "Exam Notification Letter". Exam due date is normally <u>6 months</u> from the issuance date of the Exam Notification Letter. It is recommended that candidates should contact their chosen Exam Centre immediately for reservation after receiving the Exam Notification Letter.

Exam Notification Letter

Exam Notification Letter will normally be issued to candidates **by email within 30 days** after receiving all the required registration documents and Exam Registration Fee. Please ensure that you have filled in your correct email address in this form. Contact the Board if you do not receive the Exam Notification Letter after 30 days. If you cannot find the Exam Notification Letter in your normal email inbox, check your Spam or Junk email folder before contacting the Board.

Exam Result and Certificate

A Statement of Results will normally be sent to candidates **by post within 60 days** after the examination.
